- Develop and implement training programs to build the capacity of community organizations and leaders
- Support the development of policies and strategies that promote sustainable development and resilience
- Collaborate with block administration, local authorities and stakeholders to enhance resource mobilization and policy advocacy.
- To monitor, record, evaluate work and provide reports and information as required in order to ensure a consistently high-quality provision and demonstrate the impact of interventions

- Graduates with 5-6 years of relevant work experience in livelihoods with community collectives are eligible for the Practitioner role. Those with 2-3 years of relevant experience can apply for the Associate Practitioner position.
- Experience of working in development/social sectors including government agencies with multiple offices will be preferred.
